NOW THEREFORE , in consideration of the premises and the sum of one dollars in hand paid, receipt whereof by each of us is hereby acknowledge , the undersigned does hereby undertake, agree and bond themselves , their legal representatives, successors and assigns, as follows:

1) The undersigned will have Aforesaid (Defendant) forthcoming before the above court named in said bond , attached hereto, at the time therein fixed , and from that day to day and term to term thereafter , as may be ordered by court.

2) The undersigned will at all times indemnify and keep indemnified the Surety and /or Agent and save harmless the Surety and or the Agent 100% of any and all claims , demands , liabilities , cost , legal fees , distributions , and expenses of every kind and nature which the Surety shall at anytime sustain or incur, and as well from all orders . decrees, judgments and adjudication's against the Surety and /or AGENT by reasons or in consequence of having executed such bond or undertaking in behalf and/or at the instance of the indemnitor (s) (or any of them) and will pay over, reimburse and make good to the Surety and /or AGENT , it's successors and assigns, all amounts of money required to meet every claim, demand , liability, cost expense, suit, order, decree, payment and/or adjudication against the Surety and or it's Agents by reason of the execution of such bond or undertaking, and any other bonds or undertaking executed in behalf of and/or at the instance of the indemnitor (s) and before the Surety and or Agents shall be required to pay there under. The Liability for legal fees and disbursement includes all legal fees and disbursement that the Surety and or Agents may pay or incur in any legal proceeding, including appeals , and proceedings in which the Surety may assert or defend it's rights to collect or to charge for legal fees and/or disbursements incurred in earlier proceedings. Cost of re-instatement of bond if forfeited or surrendered due to any breach of bond conditions will be no more than \$189.50 per bond. IF CASH COLLATERAL IS HELD THIS AMOUNT WILL BE SUBTRACTED.

THE UNDERSIGNED HEREBY AGREES THAT THE JURISDICTION FOR ALL CLAIMS AND DEMANDS FILED BY THE SURETY IN AN EFFORT TO COLLECT ANY OF THE ABOVE MENTIONED EXPENSES SHALL BE FILED AND ANSWERED IN THE COUNTY OF MONROE or COLLIER , FLORIDA HE HEREBY AGREES TO WAIVE ANY OTHER REGARDLESS OF THE COUNTY IN WHICH HE MAY CURRENTLY OR IN THE FUTURE RESIDE.

THE UNDERSIGNED specifically agrees to indemnify Monroe County Bail Bonds and or Agent against all negligence of the Surety and it's Agents.

The defendant hereby waives any and all civil and criminal remedies that may arise by the Surety or his Agents actions.

3) The defendant is hereby noticed that a failure to appear in the pending criminal case for which the bond was underwritten may and will be a violation of Florida Statues listed below and the Surety may and will request that the State Attorneys Office file additional charges..

Florida Statue 843.15 : Failure of defendant on bail to appear. Which may carry upto 5 years in prison in addition to the pending Criminal Charge.
